- Minimalist Wedding Package \*\*additional restrictions apply
  - Venue access 12pm- 10:30 pm, noon- 4pm getting ready time, photos, set up, 6 hr wedding ~4:00-10:00, 10-10:30 clean up
  - Access to farmhouse (excluding bedrooms), event barn, yard and lake
  - Tables and chairs for 50 guests
- Value: \$3,500-- may upgrade to a larger package by paying the difference

#### **Emily Hancock Photography:**

- Wedding Photography Package
  - Includes second shooter, 6 hr coverage, fully downloadable online gallery of high quality digital images
  - Additional hrs of coverage available for a fee
- Value: \$3,200
